ARE YOU CONCERNED ABOUT COVID VACCINATIONS FOR YOUR CHILDREN?

It must be understood: All the treatments being marketed as COVID-19 vaccines are still in Phase III clinical trials until 2023 to 2024 and hence qualify as medical experiments. People taking these treatments are enrolled in clinical trials;

None of these treatments have been approved, but only granted emergency use authorization, hence cannot be mandated nor can informed consent be dispensed with;

Most vaccines are trialed for at least 5-10 years and COVID-19 vaccines have been in trials for less than one year;

No other coronavirus vaccine (ie. MERS, SARS-1) has been approved for market, due to antibody-dependent enhancement resulting in severe illness and deaths in animal models;

Numerous doctors, scientists and medical experts are issuing dire warnings about the short and long-term effects of COVID-19 vaccines, including but not limited to death, infertility, miscarriages, Bell's palsy, blood clots, cancer, inflammatory conditions, autoimmune disease, early-onset dementia, convulsions, anaphylaxis, and antibody dependent enhancement leading to death;

Children and youth are at virtually no risk of dying from COVID-19 or transmitting it to others, but deaths and injuries to children and youth have already occurred in the COVID-19 injection clinical trials;

There have been more deaths from COVID-19 vaccines, as reported to the Vaccine Adverse Events Reporting System (VAERS), than deaths in the last 20 years from all vaccines combined;

Only 1% -10% of vaccine injuries are reported to VAERS. The full extent of adverse events from the COVID vaccines is unknown as there is at least a three month delay in uploading reports to the VAERS database.

DECLINATION OF MANDATORY EPIDEMIC-RELATED VACCINATION OF MY CHILDREN

Date: June 15, 2021

To: (NAME OF COUNTY OR DISTRICT) School Board, District Administration, School Principal, Teachers, and Staff

Re: Parental Declination of Covid Vaccination Official Notification

Any compulsory Covid-19 vaccination requirement is a violation of federal law. I urge you to advise all students, with notification of parents and or legal custodians, that they have the right to refuse to take any COVID-19 vaccine. Any other action is contrary to federal law.

In addition to federal laws, Kentucky Senate Bill 8, amended KRS 214.036 and was enacted into law on March 28, 2021. The following is a synopsis of an excerpt from the bill:

Exemptions from mandatory immunization for any child, emancipated minor; or adult who, personally by a parent or guardian, submits a written sworn statement with objection to immunization based on conscientiously-held beliefs. This bill prohibits any administrative order or executive order from requiring immunization during an epidemic if a person submits the aforementioned required document based on said beliefs.

Covid-19 Vaccines are Experimental.

Covid-19 vaccines are not approved by the FDA. The Covid-19 vaccines are only approved under an Emergency Use Authorization, for investigational use only. Covid-19 vaccines lack requisite studies and are not approved medical treatment. The FDA's guidance on emergency use authorization of medical products requires the FDA to "ensure that recipients are informed to the extent practicable given the applicable circumstances … That they have the option to accept or refuse the EUA product …"

Title 21, Section 360bbb-3 of the Federal Food, Drug, and Cosmetic Act (the "FD&C Act") vests the

Secretary of Health and Human Services with the permissive authority to grant Emergency Use Authorizations ("EUAs") providing that appropriate conditions designed to ensure that individuals to whom the product is administered are informed:

- 1. that the Secretary has authorized the emergency use of the product;
- 2. of the significant known and potential benefits and risks of such use, and of the extent to which such

benefits and risks are unknown;

3. of the option to accept or refuse administration of the product, of the consequences, if any, of refusing administration of the product, and of the alternatives to the product that are available and of their benefits and risks.¹

The right to avoid the imposition of human experimentation is fundamental, rooted in the Nuremberg Code of 1947, has been ratified by the 1964 Declaration of Helsinki, and further codified in the United States Code of Federal Regulations. In addition to the United States regarding itself as bound by these provisions, these principles were adopted by the FDA in its regulations requiring the informed consent of human subjects for medical research. It is unlawful to conduct medical research, even in the case of an emergency, unless steps are taken to secure **informed consent** of all participants.

The following Emergency Use Authorizations have been issued for Covid-19 vaccinations:

- 12/11/20 Moderna FDA issued an EUA for emergency use of the Moderna mRNA COVID-19 vaccine for recipients 16 years of age or older.
- 12/18/20 Pfizer/BioNTech FDA issued an EUA for emergency use of the Pfizer/BioNTech mRNA vaccine for recipients 18 years of age or older.
- 2/27/21 Johnson & Johnson FDA issued an EUA for emergency use of the Johnson & Johnson COVID-19 vaccine (aka Janssen vaccine) for recipients 18 years of age or older.

Each of the above EUAs was issued in conjunction with a similar Fact Sheet from the FDA. For example, the Janssen fact sheet contains the following notice:

"INFORMATION TO PROVIDE TO VACCINE RECIPIENTS/CAREGIVERS"

As the vaccination provider, you must communicate to the recipient or their caregiver, information consistent with the "Fact Sheet for Recipients and Caregivers" (and provide a copy or direct the individual to the website to obtain the Fact Sheet) prior to the individual receiving the Janssen Covid-19 Vaccine, including:

• FDA has authorized the emergency use of the Janssen Covid-19 Vaccine, which is not an FDA approved vaccine. • **The** recipient or their caregiver has the option to accept or refuse the Janssen COVID-19 Vaccine. • The significant known and potential risks and benefits of the Janssen Covid-19 Vaccine, and the extent to which such risks and benefits are unknown.

Clearly, any attempt to **force** anyone to take a Covid-19 vaccine is a violation of federal law and the conditions under which the Covid-19 vaccine has been authorized for use. The law is clear,

experimental medical treatment cannot be mandated.

Businesses are not shielded from liability with experimental agents.

Under the 2005 PREP Act enacted by Congress, pharmaceutical companies that manufacture EUA vaccines are shielded from liability related to injuries and damages caused by their experimental agents. However, any employer, public school, or any other entity or person who mandates experimental vaccines on any human being is not protected from liability for any resulting harm. While vaccine manufacturers may be shielded from liability, your institution is not protected, and neither are you.

Furthermore, any actions to restrict, alter, or segregate my child from the rest of the population of the school based on emergency use authorized covid vaccination status will be responded to with legal action against all parties mentioned above.

I urge your institution, _____, to notify all staff of the decision for my

child. Thank you for your time and for protecting the best interest of your students.
